SERVICES TO SCHOOLS - CJE PROVIDED BEST PRACTICE AND CURRICULUM CONSULTATION TO 2500 TEACHERS IN 14 EARLY CHILDHOOD CENTER, 11 DAY SCHOOLS, AND 14 RELIGIOUS SCHOOLS. THIS INCLUDED STATE APPROVED PROFESSIONAL DEVELOPMENT CLASSES FOR 400 EARLY CHILDHOOD TEACHERS. CJE ALSO RUNS A RELIGIOUS SCHOOL FOR STUDENTS WITH SPECIAL NEEDS.
