The PFA will prohibit employers from relying on salary history to set pay and promote pay transparency by protecting workers from retaliation for discussing their wages.

-Led public campaign on wage gap disparities for Black, Latinx, Native, and Asian women-and a stagnant wage gap across women of all races, produced new materials highlighting the importance of closing the wage gap.

-NWLC contributed leadership and support to solidify the passing of the Raise the Wage Act in the U.S. House of Representatives. This important legislation will increase the federal minimum wage from \$7.25 to \$15 per hour by 2024 and ensure tipped workers receive the full minimum wage before tips, which would lift women and their families out of poverty and help close the gender wage gap.

-Conducted research into the impacts of unstable and inflexible work scheduling practices on low wage workers and their families and examined state and local policy solutions and is leading an advocacy effort for passage of the Schedules That Work Act in Congress.

Legislation promotes equity and stability for working people and their families and addresses obstacles caused by unfair scheduling practices.

-Provided technical assistance, information, and analyses to help state-based advocates and policymakers secure or advance equal pay, fair scheduling, and pregnant worker fairness measures in numerous states.

-Led a policy coalition of civil rights, workers' rights (particularly low paid workers) and women's rights groups to identify needed workplace reforms to protect against sexual harassment and discrimination that were informed by discussions with employment discrimination litigators and academics. From these discussions, NWLC drafted principles and priorities for legislative reform.

-Based on this research, NWLC led the coalition in support of the development of a new bill, the Bringing an End to Harassment by Enhancing Accountability and Rejecting Discrimination (BE HEARD) in the Workplace Act, a comprehensive workplace harassment reform bill. This bill would extend protections against harassment and other forms of discrimination to more workers, remove barriers to access to justice, such as short statutes of limitations and restrictively interpreted legal standards, promote transparency and accountability, and require and fund efforts to prevent workplace harassment and discrimination.

-Provided a leading voice in print, online and broadcast media on the dynamics of workplace sexual harassment and the need for policy solutions.

-Staff testified in Congress to support the Equality Act, which passed in the U.S. House of Representatives for the first time in history. The Equality Act closes longstanding gaps in protection against sex discrimination and explicitly states that discrimination based on sexual orientation and gender identity violates federal law.

Addressing Educational Barriers Faced by Girls at the Margin-Released the new report "We Are Not Invisible," co-authored by 13 Philadelphia-based Latina middle and high school students. The report found that in 2017, half of all Latina girls were persistently sad or hopeless, and more than one in five considered suicide within the past year. The groundbreaking effort addresses the mental health crisis impacting Latina students across the country by identifying ways institutions and policymakers can support students in schools.

-Lead efforts that result in more than 100,000 comments submitted in opposition of attempts to gut Title IX protections from sexual harassment and assault in school and provided invited testimony to the Senate HELP Committee.

NWLC's leadership united survivors, civil rights groups, mental health professionals, school administrators, colleges, and elected officials in a campaign that to date has successfully delayed any final rule.

In the case of the Co-Presidents Emerita's final compensation (a portion of which is reflected in the current year Schedule J), the Center engaged a consultant who specializes in retirement-related compensation to create a compensation plan. They performed an in-depth review of peer organizations and created a compensation plan that was reviewed by outside counsel prior to extensive deliberation by the Center's Compensation Committee. The Compensation Committee also consulted with other members of the Board of Directors prior to setting the Co-Presidents Emerita's final compensation.
