Explanation: The preparation and filing of Backbone Housing, Inc.'s ("Backbone") Form 990 is the responsibility of Associated Catholic Charities, Inc ("ACC"). Backbone is one of 30 charitable organizations overseen by ACC and the responsibility for preparing and filing the Form 990's at ACC is overseen by two Accounting Managers. One of the Accounting Managers was dealing with a staffing vacancy, and during the months of November and December, ACC was in the process of moving its administrative offices. The unexpected vacancy at the staff accountant level, the additional workload and temporary distraction of moving administrative offices, and lack of a central Manager overseeing all of the Form 990s were factors contributing to one of the Accounting Managers missing the November 15th deadline for filing Form 990 Extensions. This mistake should not have happened. Backbone has a history of compliance and has demonstrated ordinary care and prudence by immediately preparing a complete and accurate Form 990, establishing central oversight, and implementing procedures and training personnel to ensure its Form 990 filing requirements are timely met in the future.
