In response to a grant request, IFSA provided \$50,000 to the fire sprinkler association of Colombia, known as ANRACI Colombia. These funds were given as the third and final year of a 3-year commitment to matching funds raised by that association as it organized itself to promote the use of quality fire sprinkler systems in that country. The funds were given to support five separate initiatives:

- 1 Improving Colombian codes and standards, including greater use of NFPA standards, and improving qualifications of fire protection technicians
- 2 Developing technical guides for building owners, contractors and institutions relating to fire sprinkler systems.
- 3 Conducting public side-by-side burns with and without automatic fire sprinkler systems to demonstrate their effectiveness.
- 4 Disseminating literature about automatic fire sprinkler systems to the public and national media
- 5 Promoting training and other initiatives to improve the technical competence of the fire sprinkler industry in Colombia.

In 2017 the IFSA had agreed to provide a grant to support a planned October 2018 conference by the Brazilian fire sprinkler association ABSpk. The total grant was in the amount of \$50,000, with \$20,000 paid during the IFSA's 2017-2018 fiscal and program year. The remaining \$30,000 was given out in this 2018-2019 fiscal and program year, in the months leading up to the successful CBSpk III conference.

The IFSA awarded a grant in the amount of \$25,000 to the European Fire Sprinkler Network (EFSN) to help support a country manager in Poland. The IFSA recognized that a country manager could help organize a nascent fire sprinkler industry in Poland so as to enhance recent interest in built-in fire suppression systems. The grant represents the second year of a 3-year commitment.
