4a. Rental Programs. CFH began owning and managing rental properties in 2008; CFH owns 7 affordable dwelling units (ADU) in Arlington and 2 in Fairfax. In addition, CFH own 7 workforce rental units in Fredericksburg. Earlier in 2019, CFH sold a duplex which it had built in 2009 and managed until the sale in January 2019. All CFH tenants fall within the low to moderating income category. CFH also co-owns its original apartment complex development, a 30-unit apartment complex in Fairfax. National Housing Trust is the Managing Partner. In January 2018, CFH purchased a mobile home park, which is providing homes to 56 households. The CFH Rental Program provides rental housing opportunities to approximately 400 individuals a year.

4b. Senior Rental Assistance. The Virginia Ely Senior Rental Assistance Program provides monthly rental subsidies to seniors whose incomes do not exceed 30% of the area median income. The participating seniors have annual incomes ranging from \$9,036 - \$24,406. Participants use 40% of their income as their rent; the program pays the balance. The current average subsidy is \$415.06. Senior participants have the ability to live independently and provide for their other basic needs. During FY 19, CFH provided subsidies to 58 senior households.

4c. DPA. CFH is completing its sixth year of administering the Virginia Department of Housing and Community Development's Down Payment Assistance Program providing assistance to first-time home buyers whose annual gross annual income does not exceed 80% of the area median income. Assistance is provided to eligible applicants in the Counties of Prince William, Fairfax, Arlington and Loudoun.

4d. NSP. The Neighborhood Stabilization Program is a Federally-funded program established as a result of the housing crisis in 2008. The program required all grantees to acquire foreclosed properties, rehab the units and sell the properties to income-eligible buyers. To date, CFH has acquired and rehabbed 23 homes; 22 have been sold; the final property is under lease-to-purchase.

4d. Community Services. The Staff of CFH is involved with organizations and clients throughout our service area. Much of this work cannot be specifically attributed to a specific CFH program, but in the overall picture serves the mission of CFH. The Executive Director serves on the Loudoun County Housing Advisory Board and the Prince William County Housing Board. She and the Office Manager are both engaged in the work of the Prince William County Continuum of Care. All staff members answer phone calls from hundreds of people requesting general help or making specific requests that are outside the CFH programs. The Staff also assists potential applicants as they are considering applying for a CFH program.

4d. Life Skills Program. For several years, CFH has administered a life skills program entitled Choices which enhances basic skills of participants in the areas of financial management, employment readiness, physical well-being and building relationships. CFH has provided this training to residents of transitional housing programs, the Prince William County Adult Detention Center and the Drop-in Center.

4d. Security Deposit Program. The Edie Streett Security Deposit Assistance Program has provided assistance to participants whose income does not exceed 50% of the area median income. The average annual income of FY 19 recipients equaled \$21,050. CFH
