ENTREPRENEUR PROGRAM - CIT concentrates on the early commercialization and seed funding stages of innovation, helping tech entrepreneurs launch and grow their companies and create high paying jobs. CIT Growth Acceleration Program (GAP) Funds place equity investments in Virginia-based technology, life science, and clean tech companies. Since the program's inception, \$28.1M in GAP investments have attracted in \$922.7M in private capital. The Virginia Founders Fund (VFF), formed in FY2018, serves underserved populations, and created 14 new startups since FY2018. CIT's Federal Funding Assistance Program (FFAP) identifies and accelerates opportunities for Virginia's small technology businesses to obtain SBIR, STTR and ATP awards and other government contracts. Program service revenue consists of proceeds on liquidated GAP investments.

COMMONWEALTH RESEARCH COMMERCIALIZATION FUND (CRCF) - CRCF invests in research and commercialization at Virginia colleges and universities, companies, federal labs, and other research institutions in their efforts to advance technology and drive economic growth in the Commonwealth. Aligned with CRCF is the Roadmap, a strategic planning tool that identifies key industry sectors with commercial promise that are worthy of economic development for Virginia. With a total program investment of over \$27M, the program has leveraged \$72M in match funding and awardees have received ~457M in follow-on funding since FY2015.

Unmanned Systems - Home to a vast array of autonomous assets, the Virginia Unmanned Systems Center of Excellence (COE) is the catalyst and collaborator driving economic expansion of this cornerstone of the Virginia economy. The COE serves as Virginia's primary information resource, and proponent, of global UMS technology, policy and trends. In FY2019, CIT and the Virginia Tech-led Mid-Atlantic Aviation Partnership continued its FAA Innovation Pilot Program on beyond visual line of sight UAS operations, with industry partners State Farm, Dominion Energy, Google Wing and others. The COE created a UMS Advisory Board with strategic stakeholders in the public and private sectors; hosted a joint workshop and demonstration with the Virginia Department of Public Safety.
