The organization builds, sells, and repairs homes for families in need. Construction and the sale of 15 homes were completed during the fiscal year ending June 30, 2019. Persons served totaled 20 adults and 25 children. Of these homes, 10 were headed by females and 1 home was headed by a Latino, 3 homes (20%) of the families were below 50% of the area median income and 80% (12 homes) were below 70% of the area median income. Two homes had disabled family members.

Nine families included African-American members, 1 family was of Hispanic descent.

Ten homes were headed by a single parent. The organization also preserved existing homes through the repair of 55 homes. This includes the homes of 1 veterans, 7 disabled, 45 elderly, and 36 families headed by females. Ten households were below 25% of the area median income, 30 households were below 50% of the area median income and seven households were between 50% - 70% of the area median income. Work in progress at June 30, 2019 included 8 home repair projects and 19 new construction homes. For the fiscal year ended June 30, 2019, 2,135 volunteers donated 70,154 hours of time.

After committee review, a copy of the return is sent to Members of the Board of Directors for their review before filing.

Form 990, Part VI, Section B, Line 12c-Each year when the financial audit is conducted, the Finance Director inquires of all officers, directors, trustees and key employees whether any conflict of interest have occurred. Additionally, vendor and donor lists are reviewed to as certain whether unreported conflicts of interest may exist. Potential conflicts are examined to determine whether these violate the Organization's policy.

Form 990, Part VI, Line 15a and b-The Organization has a compensation plan which establishes pay ranges for various classes of employees. Annually, compensation for all employees is reviewed by the executive management team. Raises are generally awarded based on cost of living, but department heads are allowed to spread raises unevenly through their department based upon merit, within strict limits. The compensation of the Executive Director is included in the compensation plan and the annual review. Wage and salary increases are presented in total and by department to the Board of Directors for approval along with the annual budget. Periodically, the compensation plan is tested against information from a regional service bureau to ensure that wages and salaries are reasonable for the Western North Carolina region. A report of this test is reviewed by the Human Resources Subcommittee of the Board of Directors and was last made during this fiscal year ending June 30, 2019. The Human Resources Subcommittee will be evaluating the compensation plan periodically to ensure that wages and salaries are reasonable for the Western North Carolina region.
