Quality Early Care and Education - Based on research showing the long-term impact on early education, the Partnership focuses on strategies that improve the quality of child care, increase access to child care for low income families and support early childhood teacher education. The Partnership also offers NC Pre-K, a quality pre-kindergarten classroom program for 673 at risk four year olds. The Partnership is a Durham Pre-K partner. Durham Pre-K is a county-funded initiative that ensures all 4-year old children in Durham County have access to high-quality pre-kindergarten. The Partnership manages two federal grants to provide full comprehensive Early Head Start services to 172 infants and toddlers (0-3) via two program models, Center-based and Home based Services.

Health, Early Intervention and Family Support - Physical and developmental health is critical to a child being in the best condition to learn. In response to this need, Durham's Partnership for Children invests in a variety of evidence based/evidence informed programs that offer support for parents and children's health and developmental interventions. The Partnership funds a continuum of Family Support programming in English and Spanish in Durham County including linking families to community resources, curriculum-based parent education and literacy series, consultation and training on children with challenging behaviors, intensive home visiting programs, case management, and child safety support. Two literacy programs provide books and encourage early literacy to reach more than 6,000 children through Dolly Parton's Imagination Library and Reach Out and Read.

4c (Code: CDCB) (Expenses \$ 392,577 including grants of \$ 870) (Revenue \$)
Community Development and Capacity Building - The Partnership funds Community Awareness and Education within its Program Coordination and Evaluation unit, both of which focus on Community Development and Capacity Building. The Community Awareness and Education program creates educational materials; develops, manages, and supports public relations activities; and coordinates events in order to build awareness of issues affecting young children and their families. The Program Coordination and Evaluation program conducts technical assistance, monitoring, evaluation, program development, data collection and analysis, and needs assessments in order to achieve program excellence and effectiveness. Several community based initiatives also fall under Program Coordination: Transition to Kindergarten, the Early Childhood Training Institute that includes the Durham Touchpoints Collaborative, the Early Childhood Mental Health Task Force, Durham's Campaign for Grade-level reading, the DELTA Collaborative, and the Collaborative to End Family Homelessness.

Monitoring. As the steward of public funds, the Partnership is responsible for monitoring its funded programs to ensure accountability of funds and compliance with contract requirements. Both the Smart Start funded programs and NC Pre-K sites are monitored annually. Smart Start Monitoring: The Partnership monitors each Smart Start funded program on an annual basis through program observation, site visits, completion of a Direct Service Provider Monitoring Tool and review of program and fiscal reporting throughout the year. The annual programmatic and fiscal monitoring site visit includes a review of the compliance with the Contract Activity Description, documentation of evaluation, compliance with communication standards, compliance with grants management, financial status reports, cash receipts, cash disbursements, competitive bidding, cash and in-kind contributions and property and equipment. Based on this review and completion of a monitoring tool, a report is completed and provided to the funded program. Follow-up technical assistance and development of a corrective action plan will occur if necessary. NC Pre-Kindergarten Monitoring: The Partnership conducts monitoring as part of the NC Pre-Kindergarten Program in Durham County. Monitoring activities for participating NC Pre-Kindergarten sites are conducted throughout the year to ensure that program requirements are met. Pre-K sites are required to complete an annual Site Monitoring Tool that is designed to address the components of the program to meet compliance areas at the site and classroom level. Sites submit the completed tools to the local contractor's office. The Partnership's NC Pre-K department reviews the tools and conducts a site visit to ensure that all information is correct and accurate and in compliance with State requirements. Monitoring tools developed by the NC Division of Child Development must also be used at the local level for self-review and verification of

(con't from page 2) compliance with operating requirements. The NC Division of Child Development and Early Education conducts on-site or desk review monitoring annually. Early Head Start - Monitoring: The Partnership, in compliance with Federal standards and administrative requirements, provides ongoing monitoring of its operations as well as those of its contracted delegate agency. It is the policy of the Grantee that all programmatic, fiscal, and management areas of the Early Head Start program are regularly reviewed and that appropriate and timely follow-up is provided to ensure correction of non compliance issues. A full monitoring review of the delegate agency is conducted by program and fiscal staff on an annual basis to assess compliance with performance standards and contract requirements. A monitoring tool has been developed using the Office of Head Start Monitoring Protocol and Self-Assessment Booklets. Monitoring includes a review of compliance with Head Start Performance Standards and compliance with the development and implementation of the financial management system. This will include a detailed review of the financial reporting accounting records, internal controls, and budget controls. The Partnership staff reviews program and fiscal data including financial status reports, financial source documentation for expenditures, monthly program updates, Head Start Enterprise System (HSES) reports, ChildPlus reports, year-end report and Performance Information Review (PIR) information. A monitoring report, including scope of testing, any issues noted, and recommendation will be provided to the delegate agency.

Background about the Partnership

Since 1995, Durham's Partnership for Children (DPfC) has created a comprehensive early childhood system that supports collaborative service delivery and planning. DPfC's mission is "To ensure every child in Durham enters school ready to succeed, we lead community strategies for children birth to 5 and their families that promote healthy development and learning and enhance access to high quality care."

The Partnership has formed strategic alliances within various sectors including government, business, medical, faith and education to integrate evidence based practices and measurable results.

DPfC is one of 75 local Partnerships in North Carolina. It is the leader charged with implementing North Carolina's Smart Start Initiative, NC Pre-Kindergarten Programs for Durham County, Durham Early Head Start, and Dolly Parton's Imagination Library. In FY 18-19, DPfC funded 10 Smart Start Programs, 40 NC Pre-Kindergarten classrooms, and Early Head Start programs with both center-based and home-based components.

Additionally, DPfC leads Durham's Campaign for Grade-Level Reading and the Transition to Kindergarten Initiative. Durham's Campaign is founded on a strong belief in the vital role of parents in achieving success for their children and is committed to engaging with families, schools, and community members to ensure better outcomes for Durham's children. Ultimately, the Campaign hopes to increase the percentage of 3rd graders in Durham reading proficiently over the next five years. Transition to Kindergarten engages a variety of community stakeholders to plan and implement transition activities for rising kindergartners and families throughout Durham. Collaborative work includes Durham Pre K, Reach Out and Read, Ending Family Homelessness, and the Early Childhood Mental Health Task Force.
