North Carolina Pre-Kindergarten (NC Pre-K) - A high quality pre-kindergarten program that serves children who are at risk and prepares them for success in school. Pre-kindergarten is a research-proven strategy for school readiness and provides educated teachers, small class sizes, low teacher-child ratios, research-based comprehensive curricula, and a focus on the whole child and family. 668 children were served during the year

Child Care Resource and Referral (CCR&amp;R) program promotes quality child care and ensures that children acquire the skills to succeed in kindergarten. This program provides services to ensure that safe, high-quality, affordable child care is available, comprehensive consumer information on child care choices; parent support and training, capacity building; technical assistance, trainings, professional development, and provider recognition and accomplishments. During the year, the achievements of this program include the following: 80 trainings provided to child care providers; 501 providers trained and 93% of providers exhibited an increase in knowledge based on pre and post-test scores; 12 facilities received on-site technical assistance to increase their star rating; 12 facilities received technical assistance to maintain their star rating; 464 instances of intense technical assistance were provided to child care professionals.

Raising A Reader (RAR) program promotes improved literacy development through daily book sharing between caregivers and young children. Books are exchanged in child care or classroom settings on a weekly basis. In the RAR program, parents are empowered with the knowledge and resources they need to help develop the foundation of academic success for their children. The totality of the program benefit children through healthy brain development, family bonding, and increased literacy skills—all proven elements for lifetime success. During the year, achievements of this program include the following: 23 classrooms from 10 facilities participated in the RAR program for a total of 266 weekly shared reading sessions; 11 parent workshops were held with 130 parents in attendance; 314 children were directly impacted by the program.
