The Center for Craft advances the understanding of craft through awarding grants, building strategic partnerships, and facilitating national initiatives in the United States. In FY19 the Center received a total of 207 grant applications and awarded 34 recipients, providing a total of \$313,771 through the Curatorial Fellowship, Craft Research Fund, Windgate Fellowship Award, Windgate Museum Internships, and Materials-Based Research Grant programs. The Center continues significant programmatic partnerships on national symposia and initiatives with the Museum of Arts and Design, Bard Graduate Center, Haystack Mountain School of Crafts, Warren Wilson College Masters-level program in Craft Studies and University of North Carolina Asheville.

Form 990, Part III, Line 4b:

The Center works regionally to advance the understanding of craft through mounting exhibitions in downtown Asheville, NC. The gallery space is free and open to the public. In addition, the Center develops educational programming and publishes interpretive materials to include exhibition catalogs. In FY19 the Center organized and mounted two exhibitions, traveled one exhibition to Arizona State University and the Minnesota Museum of Art, showcased the work of 12 artists, and recorded a total of 4,873 in-house visitors. Programs included gallery tours, art walks, workshops, book clubs, among others, serving over 706 program participants.

Form 990, Part III, Line 4c:

In February 2019 the Center began a renovation project on its 1912 historic facility purchased in 2013 to expand program space for an additional 7,000 square feet, including a second gallery, event and meeting spaces, and coworking space. The building reopened to the public on November 16, 2019. This new National Craft Innovation Hub promotes the vitality of craft in a digital age, serves as a venue for hosting national Craft Think Tanks and conferences, and provides shared office space and amenities for like-minded organizations, small businesses, and creative professionals, and has become a creative destination and resource for international visitors and the local community.
