Musiq is led by four Houston composers and community leaders to enrich and inspire the community, including youth programs, that integrate contemporary new music with other art forms. With its innovative collaborations and educational programming, Musiq strives to make modern classical repertoire accessible and vital to all audiences and musical backgrounds.

Public Performances - Musiq provided the community with ten public performances during the fiscal year. Two paid concerts were performed at the Houston MATCH facility and additional performances at Zilkha Hall, Hobby Center, Rice University and another in collaboration with the Houston Chamber Choir. Each concert included at least one world premiere work by Musiq composers and visiting artists from around the United States.  
Three Loft series concerts at the Contemporary Arts Museum reflective of current exhibitions celebrated the fourteenth season in which Musiq has provided free concerts to the community. Additionally, two "Music at the Meeting House" concerts were curated and performed in conjunction with our young artist programming.

Educational Performances - Musiq provides free outreach programming for at-risk children in the area public schools. Programming is performed for approximately 6,000 students at Zilkha Hall, Hobby Center, Houston, Texas and exposes students to musical elements and cultural diversity. Students are instructed and participate in free in-school hands-on workshops to enrich and enhance the performance programs. All programs include specific musical instruction along with foreign language instruction, music appreciation and exposure to the cultural arts.  
Additionally, about 200 students participated in the in-school residency program with Musiq teaching artists. The curriculum for these residencies was designed in collaboration with the schools as a supplement to the academic curriculum and otherwise unavailable to the regular school system student programming.
