



Part 2, 26: Part of this amount represents scholarship money that our organization holds. We give out \$500 a year which reduces the scholarship balance we have. However, this year we awarded 2 scholarships so this liability was reduced by \$1000. The other part of this amount represents money we owe to students for helping with our fundraising efforts. The students can use this money to offset some of the participation fees related to the drama program at the high school.
