MMC staff and trained volunteers provide mediation services through court-connected programs to resolve domestic relations cases and small civil claims, before a jury trial or other means of adjudication. Volunteers also may serve as a neutral third party to address workplace, neighborhood, real estate or other disputes as an alternative to the litigation process. Volunteer mediators provided over 740 hours of service valued at \$116,083 in fiscal year 2019. Clients with modest incomes are able to take advantage of a sliding-fee scale for the mediated sessions.
