During the 2018-2019 year, RE served 117 youth who participated in both school and summer programs that included but is not limited to academic programs, mentorship, STEM career exposure and personal development. On average students receive 12 hours per week of programming during the school year and more than 25 hours during the summer months. STEMWARE students enrolled in RE outpaced their unenrolled peer in 4 out of 5 math and science End of Course tests (Algebra, Geometry, Biology & Economics). On average, RE students scored 39 points higher on these tests. 100% of RE STEMWARE seniors enrolled during the 2017-2018 graduated from high school. Moreover, 100% of STEMWARE seniors whom completed programming completed post-secondary plans and are enrolled at post-secondary institutions, as compared to 25% of seniors whom did not complete RE programming. Of RE's STEMWARE students, 70% that completed programming maintained a GAP of 75% or better for the 2017-2018 year. 80% of STEMWARE students demonstrated increased knowledge on the elements of college preparedness, while 60% of students demonstrated improved decision making and responsible behaviors in personal, school and community contexts. In addition, 70% improved their understanding of STEM careers. Participation and attendance for RE students reflects a high level of commitment on the students behalf with over 63% of students attending more than 70% of programs. RE's weekly academic supports resulted in 53% of Project DREAM's students completing RE programs scored above their school peers average on the Math GA Milestone test and 50% of scoring better than their peers on the Science GA Milestone.
