(C) IF THE DECISION OF THE BOARD IS FAVORABLE, THE PROPOSER SHALL INFORM THE PROSPECTIVE MEMBER OF THE PURPOSES OF ROTARY AND OF THE PRIVILEGES AND RESPONSIBILITIES OF MEMBERSHIP IN THE CLUB. THE PROSPECTIVE MEMBER SHALL THEN ATTEND A ROTARY INFORMATION PRESENTATION AND, IF INTERESTED IN JOINING THE LAKELAND ROTARY CLUB, BE ASKED TO GIVE PERMISSION FOR THEIR NAME AND PROPOSED CLASSIFICATION TO BE PUBLISHED TO THE CLUB. (D) AFTER A PROSPECTIVE MEMBER'S NAME HAS BEEN PUBLISHED, IF NO WRITTEN OBJECTION TO THE PROPOSAL, STATING REASONS, IS RECEIVED BY THE BOARD FROM ANY MEMBER OF THE CLUB WITHIN TEN (10) DAYS, THE PROSPECTIVE MEMBER, UPON PAYMENT OF AN INITIATION FEE AND PRO-RATED DUES, AS PRESCRIBED IN ARTICLE V OF THESE BYLAWS, SHALL BE CONSIDERED TO BE ELECTED TO MEMBERSHIP. IF ANY OBJECTION HAS BEEN FILED WITH THE BOARD OF DIRECTORS, IT SHALL CONSIDER THE SAME AT ANY REGULAR OR SPECIAL MEETING OF THE BOARD AND SHALL BALLOT ON THE PROPOSED MEMBER. IF FEWER THAN THREE (3) NEGATIVE VOTES ARE CAST BY THE MEMBERS OF THE BOARD IN ATTENDANCE AT SUCH REGULAR OR SPECIAL MEETING, THE PROPOSED MEMBER, UPON PAYMENT OF THE PRESCRIBED ADMISSION FEE AND PRO-RATED DUES, SHALL BE CONSIDERED TO BE ELECTED TO MEMBERSHIP. FOLLOWING THE MEMBER'S ELECTION TO MEMBERSHIP AS HEREIN PROVIDED, THE CLUB SECRETARY SHALL REPORT THE NAME TO THE GENERAL SECRETARY OF ROTARY INTERNATIONAL. (E) THE MEMBER SHALL BE FORMALLY INTRODUCED AS A NEW MEMBER AT A REGULAR MEETING OF THE CLUB. HONORARY MEMBERS THE NAME OF A PROPOSED CANDIDATE FOR HONORARY MEMBERSHIP SHALL BE SUBMITTED TO THE BOARD OF DIRECTORS IN WRITING AND THE ELECTION SHALL BE IN THE SAME FORM AND MANNER AS PRESCRIBED FOR THE ELECTION OF AN ACTIVE MEMBER PROVIDED, HOWEVER, THAT SUCH PROPOSAL MAY BE CONSIDERED AT ANY REGULAR OR SPECIAL MEETING OF THE BOARD AND THAT THE BOARD MAY, AT ITS DISCRETION, WAIVE ANY OF THE STEPS AS SET FORTH IN SECTION I OF THIS ARTICLE AND PROCEED TO BALLOT ON THE PROPOSED MEMBER. IF FEWER THAN FOUR (4) NEGATIVE VOTES ARE CAST BY THE MEMBERS OF THE BOARD IN ATTENDANCE AT THE REGULAR OR SPECIAL MEETING, THE PROPOSED MEMBER SHALL BE CONSIDERED DULY ELECTED.

A NOMINATING COMMITTEE, CONSISTING OF THE PRESIDENT AND THE FOUR (4) IMMEDIATE PAST PRESIDENTS WHO ARE STILL MEMBERS OF THE CLUB, THEN SHALL NOMINATE TWO (2) ADDITIONAL MEMBERS.
