Every year the tour visits different farming operations to showcase the diversity and uniqueness of farming in South Florida's subtropical climate. Farm Tours are a great venue to educate the general public on modern agricultural practices, as well as the technology, equipment and management practices used on today's farms.

Dade County Farm Bureau celebrated Farm City Week with a food drive to feed migrant farm worker children. We also set up an informational agricultural display at the county commission building during the week. This Government Center acts as the home-base for Miami Dade County's rail system. This venue allowed us to connect with urban residents and share information about Farm Bureau and the issues affecting agriculture in the county.

Dade County Farm Bureau offered a food safety certification course with topics ranging from hazard analysis and critical points to preventative controls. 
