28) In November, we participated in Farm City Week held at Heritage Village in Largo. We joined forces with FNGLA, UF/IFAS, FFA, and the Pinellas County Government to educate the general public about agriculture. This years theme was small farm animals. There were multiple commodity stations set up for hands on experiences.

29) Each year we co-sponsor the annual State Floriculture and Nursery/Landscape career development day. The event is attended by students, advisors, and volunteers. At school, students are taught the fundamentals and then are given the opportunity to demonstrate what they have learned through projects and testing. The purpose of this event is to help students gain practical knowledge about the industry.

30) In a cooperative effort with the Madeira Beach Recreation Center, we have a garden club where we use lesson plans from the Sunshine State Standards to educate students on Florida agriculture. Students plant, care for, and harvest different crops based on the growing season. This program allows students to gain an appreciation of agriculture, learn to identify various plants, and become good stewards of our land.
