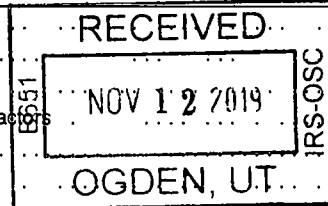



Line 28) Osceola County Farm Bureau works closely with the Cattlemen's Association on many activities. We co-hosted various leadership training opportunities. Participants visited local cattle and citrus operations as well as learn about the issues impacting these industries.

Line 29) A mini grant was awarded to help a local school with projects at Creation Kids Village. The grant helped with the project-based learning activities, which empowered students to grow and harvest their own food. The project's main purpose was to bridge the gap between the students/suburban lifestyle and Florida's agricultural community.

Line 30) Osceola County Farm Bureau participated in the Homegrown Florida program held at the county's historical society. Attendees viewed a cooking demonstration with locally grown, seasonal foods. Volunteer spoke to attendees about the history of the cattle industry in Florida and the county; learned about the current challenges in the agriculture industry; and what the industry is doing in terms of environmental stewardship and sustainability.
