PSABC will notify the property owner or registered agent and initiate scheduling by written correspondence. The property owner will be directed to reply to this correspondence either through email (director@psabc.org) or phone (828-254-2343) to schedule a date and time for monitoring to occur within 45 days of contact. On the scheduled date of monitoring, both PSABC and the property owner will be represented. The PSABC representative will have reviewed the property and easement documentation on file with PSABC, and will be equipped with photos from baseline documentation. Current condition of the property will be compared to conditions documented at the time of the easement donation. During the monitoring visit, photographs will be taken at the same or similar angle(s) of the original documentary photos within the baseline documentation added to the PSABC property file. A PSABC representative will complete a monitoring report at or immediately following this meeting, making written notes on the current condition of the easement property. Notes from discussions with the easement owner will also be documented. Within two weeks after a monitoring appointment, PSABC will send a follow-up letter documenting the on-site monitoring, property conditions, unauthorized changes, or relevant information from the property owner. If unauthorized changes have occurred or the easement property requires maintenance, the letter will urge the easement owner to contact PSABC and schedule consultation or action to address these concerns.

Pt II, Line 9	The organization receives donations of preservation easements from property owners. Preservation easements typically assign the development rights of property to the Preservation Society of Asheville and Buncombe County, thereby protecting it from development from current or future landowners. Although the removal of development rights of land has a measurable devaluation to the landowner, they have no attainable value to the Preservation Society of Asheville and Buncombe County. There is no market or market value for easements in the hands of the Preservation Society of Asheville and Buncombe County and the easements in fact impose a financial burden on the organization. Easement donors, while helping the Preservation Society of Asheville and Buncombe County satisfy preservation objectives, actually impose financial responsibilities on the organization through their ongoing monitoring requirements. Therefore, easements acquired by the Preservation Society of Asheville and Buncombe County are accounted for as "zero balance" assets and are therefore, not reflected in the organization's financial statements. The cash components received with regard to the easements are reported as income on the organization's financials.
