LOCAL COLLEGE ACCESS NETWORK THE LOCAL COLLEGE ACCESS NETWORK (LCAN) IS A CROSS-SECTOR GROUP OF EDUCATION AND YOUTH SERVICES ORGANIZATIONS AND FUNDERS FOCUSED ON INCREASING THE RATE OF STUDENTS WHO PURSUE A PURPOSEFUL POSTSECONDARY PATHWAY, PARTICULARLY AMONG THOSE HISTORICALLY UNDERREPRESENTED IN HIGHER EDUCATION. THE EDUCATION FOUNDATION OF SARASOTA COUNTY'S (EFSC) STRATEGIC FOCUS ON ITS COLLEGE, CAREER AND LIFE READINESS (CCLR) INITIATIVE, WHICH EMPHASIZES PREPARING STUDENTS SUCCESSFULLY TO GET TO AND THROUGH A POSTSECONDARY DEGREE OR CREDENTIAL, ALIGNS WITH LCAN'S SHARED MULT-SECTOR GOALS. THUS, IN FALL 2018, THE EFSC AGREED TO SERVE AS THE LOGICAL BACKBONE ORGANIZATION AND CONVENE THE LCAN FOR ITS NEXT, BROADER ITERATION WHEN ASKED BY THE EARLY FUNDERS GULF COAST COMMUNITY FOUNDATION, COMMUNITY FOUNDATION OF SARASOTA COUNTY, AND THE CHARLES AND MARGERY BARANCIK FOUNDATION COLLEGE SUPPORT AND MENTORING PROGRAM. THE COLLEGE SUPPORT AND MENTORING PROGRAM, ESTABLISHED AS A PILOT INITIATIVE BY THE EDUCATION FOUNDATION OF SARASOTA COUNTY (EFSC) IN 2019, PAIRS SARASOTA COUNTY SCHOOLS JUNIOR AND SENIOR HIGH SCHOOL STUDENT-MENTEES WITH VOLUNTEER MENTORS WHO HELP STUDENTS OVERCOME POTENTIAL HURDLES AND STAY ON TRACK TO COMPLETE THEIR POSTSECONDARY ASPIRATIONS AND GOALS. A MENTEE-MENTOR PAIRING IS ESTABLISHED AT THE REQUEST OF STUDENTS, MANY OF WHOM ARE FROM LOW-INCOME FAMILIES WHOSE PARENTS' EDUCATION ENDED WITH, OR BEFORE RECEIVING, A HIGH SCHOOL DIPLOMA, PLACING STUDENTS AT HIGHER RISK OF FAILING TO PERSIST IN THEIR POSTSECONDARY PATHWAY. MONETARY AWARDS WILL BE AVAILABLE TO SARASOTA COUNTY SCHOOLS STUDENTS WHO DEMONSTRATE OUTSTANDING FINANCIAL NEED AND ARE SELECTED FOR THE EFSC MENTORING PROGRAM. AWARDS ARE CONTINGENT ON ACADEMIC PERFORMANCE, PROOF OF POSTSECONDARY PLANS, AND PARTICIPATION IN THE MENTORING PROGRAM.
