Friends of Nazareth had 151 team members supporting numerous mission trips. These trips included: Aug. 2018 - Potter's Wheel Retreat - 13 team members and a camp group of about 160 children; Apr. 2019 - New Vision Mother's Day trip - 14 team members and about 90 3rd grade children and 100+ family members; Oct 2018 Pastors trip - 28 team members to survey NBS for mission opportunities of their churches; July 2018 Summer Camp/VBS for ~250 children for three weeks with three teams - Week 1 26 Team Members, Week 2 - 23 Team Members and Week 3 - 27 Team Members.  
Team members work with local church/school leaders to lead ministry to children and family members.

**4b** (Code: ) (Expenses \$ 192,905 including grants of \$ 245,000) (Revenue \$ 273,790)

The Nazareth Baptist School had water damage due to heavy rains in early CY 2018. This damage included a retaining wall that was failing and endangering adjacent property. The electrical system had to be replaced. Israel has historically had a major earthquake every 100 years and the last major earthquake was in 1927. Due to increased earthquake activity, the Government surveyed all schools. This review indicated the High School wing could collapse if the school experience a major earthquake. The renovation efforts included earthquake remediation efforts to the high school wing.

FON provided grants to the Nazareth Baptist School for:  
\$43,000 - Summer Camps - Four camps serving a total of about 700 children. The grant helps the school have quality camps while reducing the parents cost thus encouraging attendance.  
\$25,500 - Potter's Wheel Club - An after school program to provide educational & activities for students. The club teaches values to the kids in addition to providing activities.  
\$8,000 - Student Leadership University 101 - A student leadership program for 92 students. The object was to provide these students with leadership skills that would put them 10-15 years ahead of other gifted students.

The Executive Director's process for monitoring grants is to: a) travel at least annually, and usually more frequently, to observe first-hand the use of funded programs, build strategic processes with the NBS Board of Directors for use of funds, review financial compliance for the allocated funds, and, set goals and objectives and/or corrective actions. b) conduct monthly or bi-monthly conference calls with the Chairman of the NBS Board of Directors to discuss programs and initiatives; c) meet, at least annually, in person, by conference call or other electronic means, with FON Partners and team members to keep them informed about their partnerships assignments as well as to make them aware of upcoming ministry programs, including grants; d) encourage and equip partners to effectively conduct ministry with NBS, e) coordinate with the Nazareth Children & Family Ministry Mission team (which includes the FON President of the FON Board).
