

The Conflict of Interest policy also applies to the employees of the Minnesota Catholic Conference in terms of their employment transactions, and it requires that each employee uphold the high levels of integrity and ethical standards of the Minnesota Catholic Conference. Potential conflicts are reviewed at the supervisory level, and if a conflict does exist, the activity creating the conflict may be prohibited. If an employee fails to respond to the prohibition, disciplinary action may be necessary, up to and including termination. Any actions taken will be documented and retained in an employee's personnel file. The executive director also regularly monitors and enforces compliance with the Conflict of Interest policy.

FORM 990, PART VI, SECTION B, LINE 15: Compensation of the executive director was initially determined with consultation from an outside placements firm. Since then, the full board reviews the executive director's performance and salary every three years. After the initial hiring in 2011, reviews have occurred in 2014 and 2017. The full board deliberates together and each member completes a review sheet for the executive director. The deliberations result in a salary adjustment based on performance. The proceedings, review sheets, and resulting decision are documented and retained by the secretary of the board.
