In addition, the Coolidge Foundation provides the YMCA with the rent-free use of the land and building known as the Caroline Memorial Community Center, which is owned by the Coolidge Foundation. The YMCA uses the building as a community center and program space in Jessamine County, Kentucky. The YMCA has total control over the use of the building. The cash distributions to the YMCA are made for supporting the maintenance of and programming at the Caroline Memorial Community Center.

The Coolidge Foundation provides the YMCA with copies of its monthly investment account statements, showing its assets and all of its income and disbursements.
