Over the past fiscal year we completed 14 major conservation transactions discussed below which protected 923 acres of key mountain lands. This includes 7 fee simple purchases and 7 conservation easement purchases. The total appraised value of these transactions was \$4.2 million. Landowner donation value was \$1.3 million. The purchase price of the transactions was \$2.7 million. At times the organization purchases land below appraised value in transactions that were not planned to be bargain purchases. In this tax year that difference totaled \$0.2 million. The \$2.7 million came in the form of private philanthropic contributions and federal and state grants. We are now working on more than 20 significant transactions, which we hope will protect another 3,500 acres in the next 12-18 months.
