THE UMF AGREEMENT ALLOWS FOR THE UNLIMITED SPENDING OF FUND EARNINGS AND/OR FUND PRINCIPAL AT ANY TIME, ONLY AFTER APPROVAL OF BOTH THE PRESIDENT/CEO OF THE SYMPHONY AND THE PRESIDENT OF THE UNIVERSITY OF MEMPHIS IS GIVEN. ADDITIONAL CONTRIBUTIONS CAN BE MADE BY DONORS TO EITHER FUND ANY TIME THEREAFTER.</p>
