Once the SSS Forms have been received by the school with the estimated amount of money that the family can pay for Tuition and Fees, the Financial Aid Committee will review each case and distribute the budgeted financial aid sum among the solicitants based on the need.

The scholarships are granted to one 7th grade new student per year and are guaranteed for the rest of his/her school years until graduation if they meet the established criteria and maintain the academic and social standards originally required. The scholarship covers 50% of tuition and fees. The Financial Aid Committee is also in charge of the evaluation and selection of student who will be awarded the annual scholarship.

There is a private Corporation who is giving three scholarships with the provision that the school covers the difference if any in the tuition and fees of a selected student so it becomes a 100% scholarship. The difference between what the Corporation grants and the total amount of tuition and fees, uniforms and supplies, the school awards it as a scholarship for the student.

All awarded financial aid and scholarships information is provided at the beginning of the year to the student billing department who enters it in the student account to show the correct balance of tuition and fees due of the students.
