PUERTO RICO PUBLIC HOUSING ADMINISTRATION (Project Learn Program):
Project Learn is a comprehensive program covering educational, prevention, sports, recreational and art services. It impacted approximately 6,168 bonafide residents from different housing projects within ages 6 through 18; and 1,482 adults through its Family Support Program. Activities supported included: Power Learning (1,702 participants); Empresarism (52 participants); Drug Prevention (690 participants); Leadership Program (419 participants); Performing Arts (867 participants); Sports and Recreation (2,438 participants); and Family Support (1,482 participants). These programs are carried out through different systems including Power Hour, Torch Club, Keystone Club, Goals for Graduation, Visual Arts, Dance, Theater, and Sports and Recreation. For fiscal year 2018-19, 100% of programmatic objectives presented to PRPHA were achieved. Major programs results were: 86% of participants are in the school grade according to their age; 97% of participants graduated from high schools and 92% of those will continue post secondary studies.

VICTIMS OF CRIME ASSISTANCE PROGRAM (VOCA):
Sponsored by OJP, the program provides a psico-social curriculum through arts to help crime victims. A total of 50 participants were impacted by the program. 100% of participants were able to identify and promote empathy aspects toward their peers. The external evaluation results in a positive experience for all participants.

JUVENILE MENTORING PROGRAM (OJP)
The Juvenile Mentoring Program is a prevention and mentorship program for youth in risk. Organization provided character and leadership development, educational and career development, and health and life skills. The program benefited 123 participants from different clubs, being able to follow up on each of them individually; and 100% of participants were able to accomplish the three components required by the program.

During August 2018, BGCPR started the administration of a charter school (Vimenti) located within one of its clubs facilities. Vimenti School will cover kinder to fifth grades. The operation will be financially supported by a subsidy per student from the Department of Education and from donations from the private sector. Vimenti School is not a formal separate entity from BGCPR, but functions as another program within BGCPR operations.

(2) Page 2, Part III, Line 4d - Other Program Services: \$394,648

The Organization provides other services funded through Private Foundations, Local Governments grants and Federal Campaigns. The Organization provides drug prevention and family support programs as well as mentoring through science and other subjects.

* Prevention and Mentorship through Science (STEM): Sponsored by Sea Research Foundation, program was directed to the prevention and mentorship of youth through science. A total of 72 participants between 6 and 10 years old were reached by the program; and 81% of them attended at least 18 educational sessions.

* Volunteers Program: Program directed to capacitate volunteers through healthy habits activities. A total of 487 participants benefited from this initiative. All participants benefited from food educational activities, 8 participants completed more than 30 hours of education and 100% of programmatic objectives were achieved. In a separate module, 1,134 participants benefited, added 97 new volunteers, provided 532 hours of service

* Sexual Education and Prevention of STD: Sponsored by PR Department of Health, the program provides an educational curriculum for prevention of STD, to youth and their parents. A total of 50 youth participants and 16 parents were impacted by the program. The program achieved 100% of its programmatic objectives and 8 participants were able to document their learning experience through the "photo-voice" methodology.

* Mentorship Program to Prevent Risk Conducts: Sponsored by OJP, is an NPAL program directed to provide mentorsip to youth to prevent risk conducts. A total of 84 participants were impacted by the program. More than 72 hours of contact service were provided.

* Temporary Assistance for Needing Families: Program addressed to prevention services through SMART Modes module. Main objectives are to promote auto-sufficiency and promote strength of family relationships. Program directed to promote employment and encouragement of responsible maternity/paternity. Programmatic objectives were achieved 100%.

21st CCLC is a comprehensive program covering educational, prevention, sports, recreation and art services. Its main objective is to improve the academic progress, as well as technology skills of participants. For FY 2019, program was limited to complete tasks from prior fiscal year due to end of program.

Annually, BOD members and key employees are required to disclose if they have any interest that could create a conflict with those of the Organization. The policy is reinforced with orientations and workshops given throughout the year.

Compensation plans are evaluated every two years. In establishing compensation, a benchmark from Boys and Girls Clubs of America, statistics from the Puerto Rico Employment and Human Resources Department, and market research are used to determine reasonability. These are revised by Finance Department and Human Resources Department and the responsibilities of each position is measured against the Organization's structure. Final compensation is approved by the BOD.
