Our accountant issues monthly accounting reports to be used by the Executive Director and the Board of Directors. Every quarter we submit the Federal Cash Transaction Report. At the end of each year and on or before the 90-days after the fiscal year end, we submit the Federal Financial Report. Every year we have an external audit and the External Auditor issues Audited Financial Statements to be presented to the Board of Directors, Executive Committee, Executive Director and Accountant. Regarding the \$25,245 received and reported on Part IX Line 2, after Hurricane Maria impacted our island, the organization received this money from various organizations to help support the basic necessities of the LGBT people, granting each individual in need a \$500 help. Our staff visited the people requesting the help, to verify their specific necessity and see if they qualify.
