Alliance for Workforce Development, Inc. provides workforce development services throughout Butte, Lassen, Modoc, Nevada, Plumas, and Sierra Counties in Northern California. These services include a broad range of workforce development and community centered initiatives. This year, 65,991 individuals accessed the many services available at our 8 America's Job Centers of California. Our goal each year is to meet the needs of our communities by outreaching and providing services to as many businesses and job seekers as possible. The number of individuals requiring additional services, beyond Universal Services, and enrollment into the WIOA programs was 2,177. Our entered employment rate for individuals enrolled in our programs was 61%, with a median wage at placement of \$20.49.
