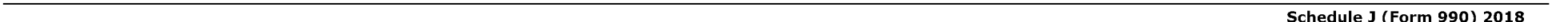

MORE PARTICULARLY, FOR THE TAX YEARS ENDING 6/30/2020 AND 6/30/2021, ST. HOPE WAS NOT ABLE TO CONDUCT ITS NORMAL FUND RAISING ACTIVITIES (INCLUDING THE ANNUAL FUND RAISING DINNER), DUE TO THE ONGOING COVID 19 PANDEMIC WHICH RESULTED IN MUCH LOWER THAN ANTICIPATED EXEMPT FUNCTION REVENUE IN THE 2020 AND 2021 TAX YEARS. GIVEN THE ONGOING UNCERTAINTY CAUSED BY THE COVID 19 PANDEMIC, IT IS MY UNDERSTANDING THAT ST. HOPE HAS CEASED PERFORMING THE ADMINISTRATIVE SERVICES TO THE AFFILIATED EXEMPT ENTITIES IN THE SPRING OF 2021, AND THAT FOR THE TAX YEAR COMMENCING 7/1/2021 THERE WILL NO LONGER BE ANY ADMINISTRATIVE SERVICE (UBTI) INCOME REFLECTED ON ST. HOPES TAX RETURN.
