ACTNWA/CAPACITY BUILDING - UNITED WAY OF NORTHWEST ARKANSAS ANNOUNCED THE APPLICATION CYCLE FOR THE 2018-2019 ACHIEVING CAPACITY TOGETHER IN NORTHWEST ARKANSAS (ACT NWA) COHORT OPENED THURSDAY, JULY 26TH. THIS WILL BE THE SECOND YEAR FOR THIS INNOVATIVE PROGRAM THAT EXPOSES NONPROFITS TO CONCEPTS SUCH AS STRATEGIC PLANNING, BOARD DEVELOPMENT, INFRASTRUCTURE MANAGEMENT, PROGRAM EVALUATION AND MORE THE NEW COHORT, LAUNCHING IN SEPTEMBER, AND WAS OPEN TO ORGANIZATIONS WITH PROGRAMS SERVING THE WORKING POOR. ANY NONPROFIT ORGANIZATION SERVING THE NORTHWEST ARKANSAS COMMUNITY IS ELIGIBLE TO APPLY, PROVIDING ITS REVENUES ARE BETWEEN \$200,000 AND \$3 MILLION EXCLUDING IN-KIND DONATIONS, AND AT LEAST A PORTION OF ITS PROGRAMMING SERVES INDIVIDUALS LIVING BELOW THE 200% POVERTY LEVEL. THE GOAL OF THE ACT NWA PROGRAM IS TO STRENGTHEN A NONPROFITS ABILITY TO FULFILL ITS MISSION AND ENHANCE ITS ABILITY TO HAVE AN IMPACT ON ITS SERVED COMMUNITY. ACT NWA ACCOMPLISHES THIS THROUGH NINE MONTHLY INTERACTIVE TRAINING SESSIONS LASTING FOUR TO SIX HOURS, DEPENDING UPON CONTENT, AND INDIVIDUAL ORGANIZATION COACHING. FTSI (FREE TAX SERVICE INITIATIVE) - UNITED WAY'S FREE TAX SERVICE INITIATIVE IS DESIGNED TO HELP HARDWORKING FAMILIES IN THE NORTHWEST ARKANSAS AREA WHO QUALIFY WITH FREE TAX PREPARATION AND FINANCIAL LITERACY. WE WORK TO ENSURE FINANCIAL ELIGIBILITY FOR THE EARNED INCOME TAX CREDIT AND OTHER DEDUCTIONS AVAILABLE TO DISADVANTAGED FAMILIES TO MAXIMIZE THEIR FUNDS. THIS PROGRAM RUNS ANNUALLY JANUARY THROUGH APRIL. UNITED WAY OF NWA EMPOWERED 4,800 WORKING FAMILY HOUSEHOLDS WITH FREE TAX SERVICES THAT CREATED AN ECONOMIC IMPACT OF \$6.5 MILLION IN REFUNDS AND TAX SAVINGS. THE VOLUNTEER INCOME TAX ASSISTANCE (VITA) PROGRAM IS AN IN-PERSON RESOURCE FOR INDIVIDUALS EARNING \$54,000 OR LESS. IRS-CERTIFIED VOLUNTEERS PROVIDE FREE BASIC INCOME TAX RETURN PREPARATION WITH ELECTRONIC FILING TO QUALIFIED INDIVIDUALS. THIS PROGRAM IS OPERATED BY CERTIFIED VOLUNTEERS AND ALLOWS OUR NEIGHBORS THE OPPORTUNITY TO FILE AND DIRECT DEPOSIT THEIR TAX REFUND FOR FREE AND ENSURE PROPER TAX CREDITS ARE UTILIZED. MYFREETAXES.COM CAN BE USED TO FILE FEDERAL AND STATE TAXES IN ALL 50 STATES FOR THOSE EARNING \$66,000 OR LESS. YOU CAN LOG ON 24/7 TO MYFREETAXES.COM AND FILE YOUR TAXES FOR FREE! TAX FILERS RECEIVED \$5.8 MILLION BACK IN STATE AND FEDERAL RETURNS IN 2017. OF THE TAX REFUNDS PREPARED, \$1.6 MILLION WENT BACK TO HARDWORKING FAMILIES THROUGH THE EARNED INCOME TAX CREDIT (EITC). EITC IS THE LARGEST ANTI-POVERTY PROGRAM IN THE UNITED STATES. FILL THE BUS - FILL THE BUS IS A COMMUNITY WIDE SCHOOL SUPPLY COLLECTION DRIVE THAT THE UNITED WAY OF NORTHWEST ARKANSAS DOES FOR 2 DAYS PRIOR TO THE SCHOOL YEAR.
