Smaller amounts go to transportation, healthcare, testing fees, funerals and other similar needs. Emergency assistance also refers people to other programs and agencies as appropriate. In addition, emergency assistance helps individuals and families sign up for government benefits like food stamps, SSI, subsidized housing and unemployment benefits.

4b (Code:) (Expenses \$ 123,578 including grants of \$ 0) (Revenue \$)
 The adult learning center/career development is funded largely by state and federal funds through the Louisiana Community and Technical College System. The programs help adults improve their basic academic skills, prepare for the state's high school equivalency exam, prepare for employment or post-secondary educational or training programs.

 Our after-school youth recreation program provides a safe, supervised place for neighborhood children to play after school lets out. It runs weekdays from 3 to 6 30 PM. Youngsters have a variety of activities in which they can participate: basketball, volleyball, table games, arts and crafts, videos and use of computers.
