CLINIC STAFF ASSESS, DIAGNOSE, AND DEVELOP INDIVIDUALIZED TREATMENT PLANS FOR EACH PERSON SERVED. PSYCHIATRIC SERVICES ARE COMPLEMENTED WITH CARE/CASE MANAGEMENT AS WELL AS GROUP AND INDIVIDUAL COUNSELING SERVICES.
