Monte Cassino Charitable Trust also contributes each fiscal year to support capital projects and general operations. For fiscal year ended June 30, 2019, tax year 2018, Monte Cassino Charitable Trust awarded \$147,500 to the scholarship fund for the 2018-2019 school year, and \$147,500 for capital expenditures, also for the 2018-2019 school year. The gross contribution of \$295,000 was paid in July 2018.
