Form 990, Part III, Line 4a:

Senior Services includes the Meals on Wheels program and the AniMeals on Wheels program. Meals on Wheels delivers nutritious weekday meals to homebound seniors and disabled individuals across five counties, as well as breakfast and weekend meals to the most frail and isolated seniors. IMGH delivered over 1.6 million meals, with an average of 4,250 seniors served each weekday. Over 1,200 individuals received additional breakfast and weekend meals to supplement their daily lunch delivery. Approximately 5,300 seniors were assessed by IMGH's social services staff for nutritional and non-nutritional needs, and many were provided case management services and referrals to partner agencies for additional services. IMGH's special Thanksgiving meal, which was delivered almost exclusively by volunteers, brightened the holiday of 4,250 seniors. Meals on Wheels participants also received shelf-stable meal boxes in the summer and winter in case of weather emergencies. IMGH delivered thousands of donated items to seniors, including fans, blankets, medical supplies and holiday gifts. The AniMeals on Wheels program delivers pet food to seniors with pets, so they will not have to share their limited food resources with their animal companions. This volunteer-driven service delivered 123,000 pounds of donated pet food to 1,300 pets, and 22 pets received preventative veterinary care. The Senior Services program received \$14,000 in donated facility space during this fiscal period.

Form 990, Part III, Line 4b:

The Refugee Services program assists in the resettlement of refugees fleeing their homeland in fear of political, social or religious persecution. Services provided include food, housing, transportation and medical assistance, donated furniture, home furnishings and clothing, cultural orientation and case management, vocational training and employment assistance, translation and educational assistance, and other services designed to help refugees become self-sufficient within six months of arrival in Houston. Refugee Services partners with local congregations and civic groups to welcome refugees, and the program staff speaks 19 languages, making refugees feel more at home in Houston. IMGH resettled 206 refugees from 19 countries, over 90% of whom were self-sufficient within six months. IMGH also assisted another 1,354 clients with case management, employment and other supplemental services, for a total of 1,560 individuals served. The Women's Empowerment group held regular gatherings for 62 refugee women to help overcome social isolation, learn new skills and promote independence. The Refugee Services program received \$29,000 in donated refugee housing and \$11,000 in donated legal services during this fiscal period.

Form 990, Part III, Line 4c:

The Interfaith Relations and Community Partnerships program fosters understanding, respect and engagement among people of all faiths through educational opportunities and community service. Almost 600 people from diverse faith backgrounds participated in IMGH's community programming, including Dinner Dialogues where participants learn about one another's faiths over a shared meal. IMGH engaged 375 emerging leaders through activities like the ILEAD Day of Service and the IMpulse young professionals program. IMGH's Multi-Faith Council, a network of 60 allied communities of faith representing 21 faith traditions, supports the program's work through direct service, dialogue about respect and tolerance, and advocacy. The Interfaith Relations program impacted over 3,000 people through partnerships, facilitation and resourcing. Volunteer Houston, the local Points of Light affiliate, connects community volunteers with local nonprofit organizations in need of assistance. Volunteer Houston registered almost 16,000 new volunteers, registered 129 new partner agencies, and matched over 17,000 volunteers with partner agencies. The Interfaith Relations program received \$5,000 in donated advertising during this fiscal period.
