To monitor the contributed bingo proceeds, the organization board of directors will receive reports from PHCS at scheduled meetings of the Organization board of directors. PHCS will administer the contributions in accordance with the terms of the pledge. Reports to the Organization will describe the support services funded by the contributions and detail the expenditures from the contributions for the support services.

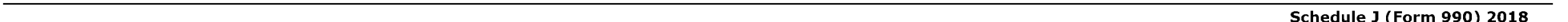
