Housing Matters By-Laws

Approved by the Board of Directors September 26, 2019

Article 1. Name

The name of this organization shall be the Housing Matters, which is a 501(c)3 organization incorporated in California.

Article 2. Purpose

The Housing Matters is dedicated to the coordinated provision of services for homeless persons. The goal of the Housing Matters is to provide both emergency and transitional services to homeless individuals and families that will enable our clients to achieve self-sufficiency.

Article 3. Membership

This corporation shall have no members.

Article 4. Board of Directors

The Board of Directors shall consist of no fewer than eleven and no more than twenty-five Directors. The Board shall reflect the diversity of the community and shall include representation from the homeless community.

Article 5. Election and Terms

Any vacancy on the Board may be filled by the Board through a majority vote at any Meeting of the Board. Directors shall serve three-year terms, and a Director may request to be re-elected for an indefinite number of consecutive terms.

Article 6. Meetings of Directors

Regular meetings of the Board shall be held at least every two months at a time and place that has been designated by the Board or in the notice of the meeting.

One-third of the current number of Directors shall constitute a quorum for the transaction of business.

Every decision made by a majority vote of the Directors present shall be regarded as an act of the Board.

The Executive Committee, when it is in the interest of the organization to do so prior to the date of the next meeting of the Board, may act on behalf of the Board by majority vote on all matters allowed by law with the exception of electing or removing Directors or officers, provided that notice of the potential action is sent to all Directors in advance of any action taken and whenever possible 48 hours in advance. Three of the current officers of the organization shall constitute a quorum for the transaction of business by the Executive Committee.

Any meeting of the Board may be held in whole or in part by conference telephone or similar communications equipment as long as all Directors participating in the meeting can communicate with one another.

Special telephone meetings of the board may be held, provided 48 hours' notice is given to the all directors. Special in-person meetings of the board may be held with less than 48 hours' notice to all directors, provided a written waiver of such notice is obtained prior to the meeting from all directors not in attendance.

Article 7. Officers

The officers of the corporation shall be a President, a Vice-President, a Secretary, and a Chief Financial Officer. The Executive Committee is made up of these four officers. Any number of offices may be held by the same person, except that neither the Secretary nor the Chief Financial Officer may serve concurrently as the President.

The Officers shall be chosen by the Board two months before the beginning of the fiscal year, and shall serve one year terms at the pleasure of the Board.

The President shall preside at all meetings and carry on other duties connected with the office.

The Vice-President shall have all of the powers of the President in the President's absence.

The Secretary shall keep the minutes of the proceedings of all Board and Executive Committee meetings and may conduct the correspondence of the Board.

The Chief Financial Officer shall receive all contributions and administer all funds as directed by the Board.

Officer and Committee Lead positions begin on the first day of the fiscal year in July and end on the last day of the fiscal year in June each year.

The Directors shall not be personally liable for the debts, liabilities, or other obligations of the corporation.

Article 8. Removal from Office

A Director may be removed from the Board for any reason by a majority vote of the Directors then holding office.

Article 9. Committees

There shall be four Standing Committees: "Finance and Administration" for internal topics such as finance, personnel, and facilities; "Development" for external topics such as fundraising and public relations; "Governance" for attracting new Directors, training and evaluating the Board, and overseeing Board operations by such activities as reviewing and keeping current the By-laws; and "Programs" for evaluating existing programs, reviewing possible modifications and additions to current programs, and receiving input from program participants to assist in evaluation and program modification discussions. Standing Committees shall make recommendations to the Board in their respective areas. Standing Committees shall meet at least once every two months. Any Director may join any of the Standing Committees. Standing Committee members shall be recorded by the Board meeting minutes. Ad Hoc Committees may be established by the Board as needed.

Article 10. Amendments

The By-laws may be amended at any meeting of the Board by a majority vote of the Directors then holding office, provided that notice of the proposed amendment is mailed or sent electronically in advance to all Directors.

Article 11. Fiscal year

The fiscal year of the corporation shall begin on the first day of July and end of the last day of June in each year.

Article 12. Execution of Instruments, Deposits, and Funds

The Board of Directors, except as otherwise provided in these Bylaws, may by resolution authorize any officer or agent of the corporation to enter into any contract or execute and deliver any instrument in the name of and on behalf of the corporation, and such authority may be general or confined to specific instances. Unless so authorized, no officer, agent, or employee shall have any authority or power to bind the corporation by any contract or agreement or to pledge its credit or to render it liable monetarily for any purpose or in any amount.

The Board of Directors shall designate by resolution who shall have the authority to sign checks, drafts, promissory notes, orders for the payment of money, and other evidence of indebtedness of the corporation.

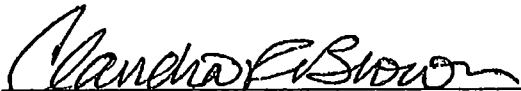
All funds of the corporation shall be deposited from time to time to the credit of the corporation in such banks, trust companies, or other depositories as the Board of Directors may select.

The Board of Directors may accept on behalf of the corporation any contribution, gift, bequest, or device for the charitable or public purposes of this corporation.

The Board of Directors shall at all times maintain Directors and Officers Liability Insurance in the minimum amount of \$1,000,000.00.
