Lessons and teaching programs. This year we experienced the devastating death of our head pro in Feb 2019. KVTA hired many part-time pros to fill his shoes. These tennis professionals instructed many juniors and adults.

Lesson and clinic attendance was strong for both juniors and adults. The variety of tennis professionals was particularly appealing for High School players. High school players are using our facility more and their training shows in their skills improvement and success in HS tennis matches. We had eight girls and three boys in the season-end Maine HS Singles Tournament.

Events. KVTA is home to several men's and women's USTA League teams this year: two 7.0 Mixed teams, an 8.0 Mixed team, a men's 3.5 team and a women's 4.0 team. We also had a Junior USTA League team for high school players, and there were three small adult tennis tournaments held at A-Copi, as well as two in-house Scrambles.

We hosted three pickleball tournaments, attracting more than 100 players each.

We also hosted a Kennebec Valley Chamber of Commerce After Hours event to raise the community's awareness of KVTA and its tennis and pickleball facility, A-Copi Tennis and Sports Center. We had food and beverages catered for this event.
