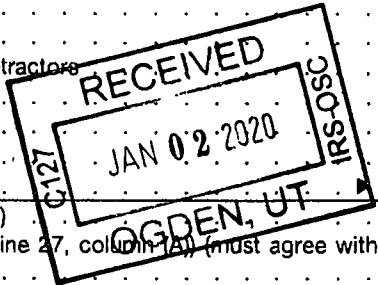

This year we filmed 20 new short-format, broadcast-ready videos of remarkable women speaking about the unsung women who inspire them, bringing our total number of videos of incredible women's stories to 97. During this fiscal year, 19 new videos premiered through our website and social media channels for unlimited online viewing. In total 19 female storytellers were featured in videos that were created by a team of four directors, one director of photography, two sound recordists, two sound mixers, 14 editors, one colorist and two production assistants. Our videos of remarkable women were viewed approximately 1.6 million times this year on the Look What SHE Did! website and social media channels, as well as online through our partnership with Participant Media.
