The WRA in partnership with several of its Member coalitions helped promote and put on several events promoting recovery including Hands Across the Bridge, Speak out for Recovery, Recovery In Action and an elected official education day in Olympia Washington. The WRA also hosted two Statewide Summits that included people from across the State working to achieve our vision of Recovery being a reality for all. Finally the Washington Recovery Alliance, under the leadership of WRA board member Alan Muia, was instrumental in launching a new organization, the Washington Alliance for Quality Recovery Residences, WAQRR. The vision for WAQRR grew out of a need for universal access to an organized database of transparent, high quality recovery homes for individuals in early recovery from substance use disorder.
