CODING EDUCATION IN IRAQ: FROM JULY 2018 TO JUNE 2019, WE TRAINED OVER 60 MEN AND WOMEN IN IRAQ IN 4 DIFFERENT PROGRAMS - ANDROID APP DEVELOPMENT, ADVANCED ANDROID DEVELOPMENT, BLOCKCHAIN, AND WEB DEVELOPMENT. THESE PROGRAMS RUN AS BOOTCAMPS AND ARE 5 MONTHS LONG. THE GOAL IS TO PREPARE STUDENTS WITH MARKET SKILL ALLOWING THEM TO WORK IN THE TECH INDUSTRY AFTER GRADUATION. IN ADDITION TO CODING PROGRAMS, WE ALSO TRAINED A FEW HUNDRED PEOPLE IN SHORTER CODING WORKSHOPS.

OTHER PROGRAMS IN IRAQ INCLUDED THE OPENING OF A CO-WORKING SPACE IN ERBIL AND NATIONWIDE HACKATHON. THE PURPOSE OF THE CO-WORKING SPACE WAS TO ALLOW FOR A GROWING COMMUNITY OF CREATIVES, DEVELOPERS AND DESIGNERS TO LEARN AND WORK FROM THE SAME SPACE. AS OF JUNE 2019, THE CO-WORKING SPACE HAD OVER 40 MEMBER AND HAD HOSTED SEVERAL DOZEN WORKSHOPS AND EVENTS. FROM APRIL 25-27 2019, WE ORGANIZED A NATIONWIDE HACKATHON IN 5 CITIES IN IRAQ: ERBIL, MOSUL, SULEIMANIYAH, BASRA, AND BAGHDAD. LOCATIONS OF ACTIVITIES WERE ERBIL, QARAQOSH, SULEIMANIYAH, BASRA, AND BAGHDAD.
