In FY19, The Bail Project, Inc. expanded its portfolio of sites with the addition of 6 new cities, increasing its capacity to bail out thousands more people every year. In addition, the organization developed its national programmatic strategy in several areas through the recruitment of key positions in its Data, Policy, and Operations departments. From the launch of its inaugural site in January 2018 to the end of its second fiscal year in June 2019, the organization provided free bail assistance to 4,602 people in 5,350 cases, including 4,128 individuals in 4,791 cases in FY19 alone. 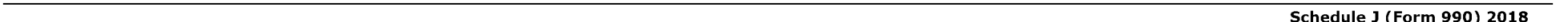
