In fiscal year 2019, Constellation Fund staff built grantmaking processes for a pilot grant cycle. Constellation's staff worked on the development of methods and procedures to estimate the economic impact of potential non-profit partners. This research consisted of identifying and summarizing evidence of the effectiveness of non-profit programs, identifying demographic characteristics of low-income individuals, and designing protocols to capture monetary benefits for these individuals. Constellation Fund awarded grants to three nonprofit organizations totaling \$243,730, with no restrictions on the use of funds, a rare form of capital in the philanthropic sector that allows the organizations to grow their impact purposefully. In addition, grantees received connections to best-in-class pro bono partners to provide services and expertise otherwise inaccessible to most poverty-fighting organizations.
