want to inform you that we have had our exempt status reinstated I was rehired to come in and fix all of the issues that had accumulated

during my absence. After completing the process of getting our status reinstated I began working on other aspects of the library and

foundation business It was discovered that there were many deposits made in our books throught the FY 17-18 that had not been actually

deposited in FY 17-18 Most of the deposits were made in August of 2018 I cannot specifically pinpoint exactly where in our revenue or

expenses that make up our difference of \$4,680 00. Also, along with undeposited funds, there were a multitude of duplicate entries into our

accounting software.
