Proceeds from these events generated \$40,500 in scholarships to Arizona colleges and universities and \$115,646 in donations to youth organizations and charities in the Yuma area. The largest event is "Midnight at the Oasis" - the southwest's premier classic car and nostalgia festival. This is a 3-day event in March attracting over 900 entrants and approximately 50,000 attendees.
