The building is now open with a reception area available for community events as renovations continue. The society has replaced the roof on the front part of the building, and has added insulation to the back bay area. The Society has also painted the back bay ceiling. During the past year the society has also worked on a brick and concrete sidewalk at the front of the building. The building now has signage and display cases of historical items donated to the society. The society continues to accept donations of items with historical significance to McCloud and the surrounding area.
