Professional Care - Completed train the trainer process for Trauma Systems and Parent Child Interaction therapy (allowing for sustainability of the model) - Four additional staff became registered play therapists (RPT) on the early childhood team - Implemented First Episode Psychosis - Started DUI classes within the Substance Use Disorder program - Aligned Evidenced Based Practices across the organization with leadership oversight. Process Improvements - Our Leadership Team has hired a Chief Strategy Officer, as well as a Vice-President of Performance Improvement.
