YOUTH UNITED (EXPENSES \$7,500 INCLUDING GRANTS OF \$7,500) - YOUTH UNITED IS A SCHOOL-BASED EXTRACURRICULAR PROGRAM THAT WAS DEVELOPED AS AN ALTERNATIVE LEADERSHIP OPPORTUNITY TO PROVIDE REWARDS AND RECOGNITION TO RURAL HIGH SCHOOL STUDENTS WHO PERFORM COMMUNITY SERVICE. STUDENTS VOLUNTEER AT LOCAL ORGANIZATIONS FOR HUNDREDS OF HOURS. EACH STUDENT WHO ACCRUES AT LEAST 100 VOLUNTEER HOURS EARNED A VARSITY LETTER AT AN AWARD PRESENTATION IN THE SPRING.
