LOCAL CAPACITY BUILDING IAF NW continued its core work of building the capacity of local leaders & organizers to improve the welfare of their local communities. That work included conducting advanced 6-Day Leadership Institutes for community leaders in the US, Canada, New Zealand & Australia, organizing 3 multi-day seminars/ training sessions for the professional organizers, & providing weekly phone consultation & on-site mentoring support to organizers & key leaders from 12 organizations located in northwestern US, southwestern Canada, Australia & New Zealand. Highlights of the work by & with those organizations include: Engaging 165 experienced leaders in six IAF 6-Day Leadership Institutes that provided comprehensive training in community organizing principles & built in-depth relationships across diverse communities. Trainings were held in Vancouver, Brisbane, Wellington & Auckland. Supporting the organizations in successful campaigns related to expanding affordable housing, creating quality living wage jobs, & increasing access to public transportation.

REGIONAL STRATEGIC INITIATIVES IAF NW continued to expand its efforts addressing health equity across the region. The organization now provides ongoing training and support for two family medicine residency programs-- at Swedish Cherry Hill in Seattle, WA and at Oregon Health & Science University in Portland, OR. This year, the programs addressed significant "social determinants of health" by tackling problems related to prescription drug labeling for people who do not read English (Oregon) and jail diversion for people with addictions or mental health problems (Spokane, WA).
