Academic Enrichment - We successfully recruited our 19th Cohort of scholars this year while continuing our earlier start initiative by having Cohorts 18 on campus throughout the academic year with students enrolling from Seattle, Renton, Highline and other surrounding districts. Meanwhile, Cohorts 16 and 17 completed their final summer in August 2018 with 100% earning placement into independent schools or highly-capable public school programs. Cohorts 18 completed their school year in 2018-2019 also achieving a 100% placement rate in college preparatory settings with 26% in public school programs and 74% earning placement at independent schools. Cohort 18 continued our increased rate of independent school placement as a result of our earlier start initiative.

College Support In this most recent year, over 170 college scholars were served through ongoing comprehensive support and outreach, 100% of freshmen received on site campus visits from Rainier Scholars staff. An essential College 101 retreat provided critical support for transition into college life. Internships and additional career networking opportunities were provided to build professional networks. We now have over 200 college graduates. 88% of our first seven cohorts have graduated within 5-6 year time frame. Rainier Scholars alumni are now employed throughout the region and the country at companies/institutions such as Amazon, Boeing, Facebook, BMGI, Accenture, Google, Liberty Mutual, Honeywell, Deloitte, Teach for America and Uncommon Schools. Other alums have graduated from medical school, law school, business school and other advanced degree programs, preparing them for leadership in their workplaces and their communities. As we look at the leaders and community members our scholars are evolving into, we feel humble confidence that our model, which begins at age 10, truly offers the opportunity for students who otherwise would not have access to the high quality college preparation and leadership development experiences, to become the young adults they want to be, and in so doing, become members who so greatly enrich our communities and our world.

High School Support (formerly Leadership Development) 95% of high school scholars who pursued internships were successfully placed. To date we have successfully placed students (high school and college) in over 500 internship experiences with the majority receiving high marks by workplace mentors. Our eleventh cohort of scholars achieved 100% high school graduation as well as 100% acceptance to four year colleges and universities, with 71% of those acceptances coming at most/more selective colleges.
